Important Terms & Conditions

1. Bookings

A booking will only be guaranteed when confirmation has been provided in writing by 3B's (Burswood, Bar & Bistro) Management.

2. Confirmation

Confirmation of a booking will be provided in writing by 3B's (Burswood, Bar & Bistro) Management ONLY when the booking deposit is paid in full.

3. Deposit

A booking deposit is required to secure clients preferred date and time of function. The deposit amount will be based on the area booked. Refer to Deposit Schedule for amount.

4. Food Payment

Selected food items for function are to be paid in full 14 days prior to function date. If payment is not received 14 days prior, food selection may not be able to be guaranteed.

5. Cancellation

- a) Booking Deposit is nonrefundable.
- b) Food Payment – A full refund will be provided if cancellation is made in writing and received by 3B's (Burswood, Bar & Bistro) Management no later than 21 full days **prior** to function date. Cancellations made between 21 and 14 days prior to functions will forfeit the cost of any food items already ordered for the function. Cancellations between 14 days and date of event this will be nonrefundable.

6. Payment of final account

A valid credit card must be provided to 3B's (Burswood, Bar & Bistro) Management 24 hours prior to date of function.

7. Bar Tabs

A valid credit card must be provided to 3B's (Burswood, Bar & Bistro) Management to hold behind the bar. The venue reserves the right to request interim payment of tabs if it deems the tab is rising beyond either an agreed threshold or at the discretion of the Venue.

8. Catering

All function food and drinks are to be provided by the Venue. No outside food or drinks will be allowed to be consumed on the premises. Requests for celebration cakes can be

made to the venue. Surcharges will be incurred for personal supply of a celebration cake, cutting or serving. Refer to Function's Menu & Charges.

9. Music

DJ/Live music can be accommodated, however, must meet noise level restrictions imposed on the venue due to its location in a residential high-rise/built up location. Any breaches incurring costs will be passed onto the Customer/Functions Organiser.

10. Event Set Up/Decorations

Freestanding decorations are welcome at the Venue. No decorations are to be nailed, pinned, screwed, glued or attached to walls, doors or any areas within or external at the Venue. Table scatters, glitter and party poppers are also not permitted. We will try to accommodate any special requests at the discretion of 3B's Management.

11. Security

Security is not required for functions of 75 people or less. Where a special license is sought and received for attendees over 75 persons, security is **required** and is at an additional cost to the Client. The function cannot proceed until security booking confirmation is received. We are happy to assist the Client securing security services.

12. Liquor Licensing

The 3B's (Burswood, Bar & Bistro) is licensed to serve Alcohol and as such must abide by the Liquor Control Act 1988. It is an offence to sell or supply liquor to a person under the age of 18 years on licensed or regulated premises, or for the person under the age of 18 to purchase or attempt to purchase on licensed or regulated premises.

The 3B's (Burswood, Bar & Bistro) Management and staff reserves the right to request a current photographic Drivers Licence, Valid Passport or WA Department of Transport Proof of Age Cards. Please NOTE: NO over 18+ cards will be accepted.

The 3B's (Burswood, Bar & Bistro) is a responsible server of alcohol who takes the safety and wellbeing of both staff and patrons seriously, as such The 3B's (Burswood, Bar & Bistro) Management and Staff reserves the right to:

- a. Refuse entry and service to underage persons
- b. Refuse service to intoxicated persons
- c. Remove any person creating disturbance
- d. Refuse service to and remove any person demonstrating aggression

The 3B's (Burswood, Bar & Bistro) venue is licensed for up to 75 persons. An extended licence to host between 75 and 120 persons can be applied for. Extended capacity

liquor license must be made through application to Racing, Liquor & Gaming. Approval can take from 2 weeks upwards. Cost of application is responsibility of Client/Function Organiser.

13. Delivery/Removal/Pack up of goods eg Decorations/Birthday cakes

The 3B's (Burswood, Bar & Bistro) has limited storage space and kindly requests that all delivery of goods is organised no earlier than one day before date of function. If deliveries arrive prior, they will NOT be accepted/received. It is the responsibility of the Client to coordinate and accept/receive delivery of goods.

The 3B's (Burswood, Bar & Bistro) Management and Staff will not be responsible for the condition of any goods or services delivered to the venue.

Removal of all Client supplied goods is required to be completed by 10.30am the following morning.

14. Damages/Loss

Clients are responsible for all damages sustained/caused by their contractors and guests whether during set up, during the function or during pack up.

The 3B's (Burswood, Bar & Bistro) takes no responsibility for damages to or loss of any of the Clients, contractors or guests property/belongings left on the premises before, during or after the function.

15. Code of Conduct & Dress Code

The 3B's (Burswood, Bar & Bistro) Management & Staff reserves the right to refuse entry or service to any person or persons failing to comply with the following dress requirements:

- a. Neat and clean clothing at all times
- b. Footwear to be worn at all times
- c. No outlawed motorcycle club colours, club insignia, tattoos or patches to be worn or on display
- d. No obscene or offensive clothing

16. Theme/Costume

Please discuss with The 3B's (Burswood, Bar & Bistro) Management. While we try to accommodate requests, all theme acceptance for functions will need to be vetted and approved by The 3B's Management.

18. Smoking

The premises is totally NON-SMOKING. To accommodate our smoking clientele an outside designated smoking area has been set up. This is the only area smoking will be tolerated.

19. Cleaning

General cleaning, such as vacuuming, table clearing and wipe down, is included. Cleaning outside of this scope, such as vomit or where special cleaning equipment or services is required will be the responsibility of the client/functions co-ordinator.
